## Request for Proposals (RFP) for Developmental Masterplan for The Nairobi Club

#### Introduction

#### Background

#### **Objectives**

#### Scope of Work

The consultant will be expected to:

- 1. **Conduct a comprehensive assessment** of the Club's current facilities, operations, and market position.
- 2. **Analyze land use** and identify opportunities for optimization, including potential development projects and unique landscaping opportunities.
- 3. **Develop a conceptual masterplan** that outlines the vision for the Club's future development, including architectural concepts, space utilization, and landscaping.
- Create detailed design plans for specific areas of the Club, such as the clubhouse, dining facilities, outdoor landscaped mini-parks and niches, sports facilities, and accommodation.
